Vice President's Report

Welcome back to another beautiful summer at the lake!

The threat of non-native species invading our lakes is one every member of CLPLPOA should be concerned about. We already have significant issues with Eurasian Milfoil and Carp in our lakes, but other species like Red Goby (fish), Quagga and Zebra Mussels, Rusty Crayfish and Hook -Tailed Water Fleas pose significant risks to our native plants and animals and the enjoyment of our lakes.

These invaders typically have no natural predators in our lakes, so they multiply rapidly. They also reduce the native populations of aquatic plants, fish, insects, crustaceans and shellfish and ultimately can replace native species.

So here are the things you can do to assure we, or our guests using the lake, are non inadvertently contaminating our lakes with these invaders:

• Never dump aquariums into the lake. In addition to introducing live plants, which are not native to our lakes, very harmful bacteria and viruses can be introduced as well.

- Never, ever, dump bait of any kind, or the water it was purchased with in our lakes. This includes all minnows, crayfish, worms and any other live baits. The water may also contain diseases organisms. So always dispose of unused bait on land. Dig a hole, pour the bait and water in and it will fertilize the area. Even "certified bait" purchased locally can have mis-identified minnows or diseases in the water, so it is vital that all bait is disposed of properly.
- When purchasing a used boat, or a new boat trialed in a lake other than ours, the boats should be power washed, drained from every conceivable place water could collect and allowed to dry for a minimum of five days before putting in our lake. On kayaks and sailboats, open the drain plugs and tilt the boat to remove all water accumulated internally on these boats. Even if you cannot see plants or animals, there are microscopic hitchhikers which must be eliminated to protect our lakes. This applies to pontoons, kayaks, sailboats, canoes even floating rafts. If it was in another lake or stream it should be thoroughly DRAINED WASHED DRIED before putting in our lakes.
- Please make sure your guests at the lake are aware of and follow these rules.

They have compiled guidelines for catch and release based on the DNR rules and fine- tuned to our specific lake conditions. See Below.

Crystal Lake/Perch Lake Association Fishing Guidelines

Species	DNR Minimum Size (in)	DNR Daily Possession Limit	DNR Legal Season	CLPL Association Guidelines
Largemouth Bass	14	5	Saturday before Memorial Day until Dec 31	Catch and release all. Great sporting fish but not the best to eat.
Walleye	15	5	Last Saturday in April until March 14	1 per day only until the population is established in a few years.
Northern Pike	24	2	Last Saturday in April until March 14	Keep all over 24 inches. Large Pike eat desirable panfish at a great rate.
Yellow Perch	No Size Limit	50	Open all year	Species is in recovery on our lakes. Daily limit of 4 on Crystal. Release all on Perch
Sunfish/Bluegill	No Size Limit	25	Open all year	Great panfish. Keep all on Crystal. Release all on Perch until population recovers.
Crappie	No Size Limit	No Limit	Open all year	Same as DNR
Bullhead	No Size Limit	No Limit	Open all year	Same as DNR
Carp	No Size Limit	No Limit	Open all year	Keep all and compost. Carp are an undesirable invasive species.
