Snow plowing was minimal, again, this year due to weather. We have been satisfied with the job Jason Sumner did this year and will be continuing the contract with him.

I would like to thank Mike Holden for maintaining the North Crystal Lake roads and mowing the North Entrance.

Thanks, also, goes to those who cleared the downed limbs during the March storm while I was enjoying sunshine in Georgia.

Dust control has been done and is scheduled for 2 more times this summer/fall as needed.

I would like to thank the property owners and Board for the opportunity to serve in the capacity of Roads Maintenance.

Due to health issues I have respectfully tendered my resignation effective July 8, 2017.

My replacement will be responsible for operation and maintenance of the Alitec and coordination of contractors which include, but not limited to: snow plowing, dust control, mowing, maintenance of the "pit", and tree/limb removal as necessary.

## Lakes - Bob Conn

Summer has arrived and so has the heat. Welcome to all our new home owner's as we look forward to meeting you and encouraging you to support the lakes with your yearly donations. We have had a busy spring in that fish stocking for both Crystal and Perch has taken place. Crystal received another 500 small mouth bass for a total of 750 YTD. Perch received 500 channel cats and both lakes received fat head minnows, Crystal 9000 and Perch 4000. I have been working closely with PLM (our lake management company) to ensure we do not use any copper sulfate based products. Perch has already had a milfoil and algae treatment. Crystal has also had a milfoil treatment. The week of June 19<sup>th</sup> is the home owner lot treatment spraying. We have been fortunate that the wet

spring has allowed both lakes to come back up to normal lake levels. Crystal was very high as the beavers were back at damming the weir, resulting in many lake front properties experiencing flooding. The beaver dam has been cleared several times to allowing lake level on Crystal to reach legally set height. In another note, if you have not donated to the lake foundation, please do so as that money is what we use to manage the overall health of our lakes.
