An email was sent out last week from Judy Moskus regarding the passing of the SAD at the August 19<sup>th</sup> township meeting. The overwhelming support of the community and the many members who attended were greatly appreciated by the board. It took several years of planning, and this will be used to support elements of the 5 Year Plan that was presented in 2018. Now that the SAD is established, the second step will take place on September 16<sup>th</sup> at 7p when the second public hearing is held at the township hall. You received a notification from the township with tax IDs to be included in the SAD. The CLPL Board used the model of the road dues with exceptions for those without any lake access. If you believe that you have a valid reason to be excluded or their list includes multiple tax IDs, this is your time to raise the objection to the trustees for them to make the final determination.

Thanks to all the road warriors out there who have spent many hours cleaning up the aftermath of the storm. My property took a brutal hit, but the trees spared the home. My husband, Stan, was known for his focus on replacing some of the old oak trees with new trees, particularly different varieties, to maintain our "Up North" feel. Someone suggested that perhaps he knocked them over. Once I rebuild the hillside, we will have a celebratory planting of 2 or 3 trees on the lakeside in his memory. There are still days of sun to enjoy this summer, so I hope to see you out there.

### ROADS' REPORT - Rick Applegate

Thanks to the volunteers, Terry Yamarino, Tom Lieblein, Chuck Hopkins, Tim Ostrosky and numerous others who help out on our road work throughout the year.

Storage of our Maintainer (Gator) is located in Dan Stevick's pole barn and has proved to be the best solution for protecting our investment now and for years to come. Thank you, Dan, for working with us to store not only the Maintainer but other equipment as well.

Dust Control is applied two or three times each year as our budget allows. Periodic rains during the summer help the effectiveness of the applications.

Mowing is done at each entrance and the two boat launches. We also have a subcontractor who mows roadside areas in mid June.

The compost area was a lifeline this year with the storm that rolled through in August. Thanks for helping keep any tree limbs 6" or larger out of the compost. Branches and small limbs only are the rule of thumb. In an effort to extend the life of the compost, we will close the area from anyone entering with a vehicle from December 1, 2021 through March 31, 2022. You will still be able to enter alongside the chain but not enter with a vehicle. Thank you for your compliance!

The paving project at the South Crystal Lake entrance may be finished by the time this report is posted. This includes resealing the north entrance.

Fall is the time for raking leaves. Please!! Do not rake leaves into roadways or burn leaves in roadways. There is a considerable amount of water from our roads that drains into our lakes.

Snow plowing for our roads is subcontracted by Precision Lawn Care. If you are interested in snow plowing your driveways or lawn care call 517-438-1309.

My coworkers and I spend a significant amount of time keeping our roads in good condition. Your help is appreciated keeping drainage areas from roads clear and roadsides free of debris and trash. We enjoy helping everyone out as much as possible, but we can't do it all. Please help us out from time to time.

### LAKES' REPORT - Bob Conn

Summer is slowly coming to an end, but the heat certainly doesn't want to let go. I only have a few comments and would like to pass along my thanks for your support of the SAD. This summer brought the usual algae blooms and large amounts of invasive pond weed to Crystal. With your help, we managed to keep Crystal in good shape for a balanced approach for all uses. Perch Lake had a much different summer as we treated it heavily to combat the Starry Stonewort which was taking over. We were successful in controlling it but at the cost of water clarity for the summer. It is my hope that Perch next year will see less nutrient load in the lake and will be back to the nice clear water we enjoy.

Please note that sun penetration into our lakes does increase plant load. I will continue to add fathead minnows into both lakes as an organic solution. One of our members asked a great question with regards to chemical contamination of our ground water and potential hazard to our wells. Many years ago James, from PLM, and I made sure not to use any chemical products like Granular 2,4D which does have well restrictions. With that said, I will do my best to ensure folks who have wells near the lake do not receive any spraying near the well as an extra precaution. Enjoy the rest of summer and fall as I always look forward to hearing your input as to how we are doing.

### SPECIAL PROJECTS – Barbara Yamarino

I'm happy to let you know I will be back on the CLPLPOA Board in charge of Special Projects. Because of the increase in COVID numbers, we will not be having a fall / winter party. Hopefully next year we can resume having many happy get togethers once again. I am looking forward to seeing you all at the fall meeting.

### **FOUNDATION**

It's been a great year for the Foundation. We have collected donations totaling \$18,150 for Lake Treatment, \$2,025 for fish programs, and \$1,800 for other special projects / areas of greatest need. Even though this may be all we need for this year's expenses, we are going to still have our annual end of the year auction. It will put us over the top and, well, it's just darn fun! The auction will be online just like we had last year. 

### LAKE STEWARDSHIP

How well are YOU protecting our lakes? Most of us think we're doing a good job of protecting Crystal and Perch Lakes, but are we really?

Lake LeAnn has been having issues with their lake. They have hired consultants and are working with MSU to improve the water quality and protect their property values by having a thriving lake. This project is focused on their shoreline to improve the natural filtration for a cleaner lake.

We have been fortunate with the leadership of Bob Conn and Dave Vanderworp to help manage the lifeblood of our lake community. But it's more than the lake manager that can affect the quality of Crystal and Perch Lakes... it is all of us that need to do our part to help keep our lakes healthy.

You can find out how your property footprint contributes to our lake health by taking the online **MICHIGAN SHORELANDS SURVEY**: (15 min)

- 1. Just go to: <a href="www.mishorelandstewards.org">www.mishorelandstewards.org</a> and click "Rate Your Shoreland" to take the survey. This can be done anonymously or you can register if you wish. \*\* You may click directly on the link within the electronic version of the newsletter to go to the survey! \*\*
- 2. Then answer a short list of questions, such as:
  - Do you maintain a natural barrier between your lawn and the shoreline?
  - Do you maintain your septic system properly, having it serviced and pumped-out every three to five years?
  - Are you taking steps to prevent erosion near the shoreline?

#### **FUN AND EASY!**

- Those of us who've taken the survey find it fun and informative.
- High scores are given a Bronze, Silver, or Gold rating, if you are into that kind of thing.
- Above all, you can learn a lot about how to protect our lakes and your property value.

### **IMPORTANCE:**

- Learn how to prevent erosion along the Shoreline Zone.
- Get a better understand of the importance of trees and native plants in a wide **Buffer Zone**.
- See the connection between hard surfaces in the Upland Zone and increase runoff going into the lake.

#### **BENEFITS:**

- Learn which PAST actions you've taken that protect our lakes.
- Get customized recommendations for which NEW actions you can take to do an even better job.
- This survey is full of background information, definitions, and tips, which will answer almost any question you have about what beneficial shorelands look like.
- Our lakes will be better off when many of our homeowners take action to improve their property.
