Bylaws

Patty Maher and **Marty Mulloy** have done an excellent job of spearheading the update of our bylaws. Our association membership received the proposed bylaw draft April 29, 2022 on our association website and those without emails received a letter in the mail.

Thanks to all who attended the special bylaw meeting on Saturday May 28th. The meeting was well attended with approximately 30 of our Perch and Crystal Lake homeowners. We received some excellent feedback from all along with emails from those property owners who could not attend.

The main discussion points were Road Maintenance fees, Financial Signoff Authorities, No Wake and Short-Term Rentals.

PRESIDENT'S REPORT, continued - Kevin McMaster

- Road Maintenance Fees Current bylaw states "that fees will be assessed on a per owner basis; owners with multiple lots will pay the same amount as a single lot owner." The board believes we need this updated to make this more fair and equitable to all. There are 188 lots where we maintain the roads. Due to multiple lot ownership we only collect maintenance fees on 123 lots. There are 65 lots, 35%, are mostly subsidized by single lot homeowners. Our proposal is to assess on a per lot basis: lots with a dwelling will be invoiced the full fee and vacant lots will be prorated at \$50 for a single lot and \$25 for a half lot. This will affect 4 owners with multiple dwellings and 38 owners with vacant lots. This change will more fairly distribute the road maintenance fees.
- Financial Signoff Authorities Current bylaws states "any amount over \$10,000 the board would need approval of the Association membership." We felt this amount was too low given some potential emergency issues like tree storm removal, road wash outs, septic tank failure in our lakes, road grader etc. These issues would need an immediate response with little time to get the association together. The Board is recommending \$39,999 to cover upper end emergencies.
- No Wake Designation This concern relates to both the speed of current boats on the lake and future personal watercraft. As electric technology becomes more sophisticated, operating at high speeds, this could have a major impact on our community and lake activities.
- Short Term Rentals Association Rules All real property within
 Crystal and Perch Lake is zoned residential use only. With the increased
 popularity of Airbnb and VRBO, we wanted a rule that stated no short
 term rentals are permitted.

The CLPL Board main objective on the bylaw update was a good faith effort to modernize our bylaws for the future with our association purpose and mission statement in mind. The vote for the proposed bylaws will be at the upcoming annual summer meeting, July 9, 2022.

VICE PRESIDENT'S REPORT - Patty Maher

I suspect like many of you, I am ready for some relaxation out on the Lakes this summer. I look forward to floating, swimming, paddling, flotilla / boat parading, or other community events in the upcoming weeks. And, I may even try learning to fish again! I will definitely reach out for some help from the experts on the lake for some tutelage, if I take this up.

Marty Mulloy, Co-chair of the ad hoc bylaws committee, and I have been consistently working with the Board of Trustees to prepare a final document for vote at the upcoming annual meeting on July 9th. As you may recall, the committee was convened by our President, Kevin McMaster, after the fall Association Meeting.

To summarize, here are some of the key steps in the process used to prepare the bylaws.

- Three initial meetings with the Co-chairs (Mulloy and Maher) to outline a plan for collecting input from key stakeholders held in the early fall.
- Over the next 3 months we then held over 24 hours of one on one or small group input meetings (~10 meetings) with the current and past Board members.
- Consulted other neighboring association bylaws for some benchmarking.
- Provided a status article in the Spring Association Newsletter.

- Briefing on status and process to all Association Members at the Spring Meeting (April 23)
- Draft of the possible changes to our bylaws for consideration and comment distributed and posted to all Association Members (April 29)
- Special Association Meeting to hear input, discussion, and take questions on the draft bylaws (May 28)
- Feedback from special meeting and written input from Association Members were integrated into a final draft.
- The final draft of the bylaws was posted to Crystal-Perch Lake website and distributed to all Members (June 9)

ROADS' REPORT – Rick Applegate

Our 3.1 miles of roads can be challenging with the variety of weather conditions that we experience. Currently, we are trying not to disturb our recent dust control application. Due to hard rains, we will have to grade and repair as necessary.

I have been struggling with Hillsdale County Road Commission to clean up fallen trees on the guardrails along South Jackson Road between north Crystal Lake entrance and south Crystal Lake entrance. It is quite an eye sore. Hopefully, the Road Commission will follow through with their verbal commitment to clean up South Jackson Road over the next couple months.

Summer brings more visitors. Please advise your guests and any contractors or workers of the 15 MPH speed limit.

One request from the road guys is *Please Maintain Your Mailboxes* and keep our roadsides free of debris. The next time you go for a walk, take a plastic bag on your walk and help us clean the roadsides of debris and cans. We want our environment to be as clean as the lakes we share and swim in.

LAKES' REPORT - Bob Conn

Just a quick update on what has happened since my spring report. Several Crystal Lake folks have caught some Rainbow Trout that were stocked earlier. The entrance into Little Crystal and the channel to the Bias home have been treated to keep them both open. Perch Lake has had a major treatment as part of a 4-year plan to reduce the impact of Milfoil.

The next three years result in Herbicide spot treatments lessening the impact of Herbicides on the Lake life. Crystal has already had its first evasive weed treatment with the hopes that the Domestic Large Leaf Pond weed doesn't get so out of control that we require weed harvesting or large treatment. Stary Stonewort is very visible in Crystal impacting fish spawning areas. I would encourage where possible to rake some areas in front of your homes to allow for fish spawning to occur.

Have a great summer, and I look forward to several more years looking out for our lakes.
