## **Bald Eagle Update**

The 2 baby eaglets are now between 8-10 weeks old. They have lost their grey thermal down, and their entire bodies are covered in juvenile feathers. They are quite large and like to sit on the edge of their rather large nest. They should be ready to fly in the next 2-4 weeks. There is great viewing of the eagles' nest on Crystal Lake by the McMaster and Carr lake homes.

## **Lake Light Pollution**

We all love the new lights available from Home Depot and Menards. They make it safe for us to see getting around our patios and walking to our decks, docks and homes. Please be aware that leaving lights on all night can affect your neighbor's enjoyment of their time on our lake. Even though our lake is almost a half mile wide, some lights across the lake are bright enough to read by and can light our neighbors' bedrooms. LED yard lights transmit light waves much farther than traditional incandescent lights and watt for watt much brighter. We all share the lakes that we love. Please be considerate to turn lights off when you aren't using them, don't have them on from dusk to dawn, and use a light sensor on security lights so they will come on and go off after the person/deer/raccoon has moved on.

- Security lighting should be installed to activate by the motion of a large animal and then shut off quickly if further movement is not detected. Do your best to install so "light trespass" onto our lakes or neighbors' properties doesn't happen.
- Landscape lighting should be low level, light only walkways and not be pointed toward the lakes.

We have received road dues from all but one (1) member of our association and 24 out of 28 members for administration dues for this fiscal year. Thank you to everyone for your cooperation and patience during this period with the changes instituted from our new By-Laws.

We will begin invoicing for the 2023-24 fiscal year shortly after our summer meeting. Invoices will once again be going out via email. This was a huge cost and time savings for the Board. ## ROADS' REPORT – Rick Applegate

Thanks to all of our road volunteers, we are able to maintain and care for the 3.1 miles of private roads around our lakes. A special thanks to Terry Yamarino and Frank Dietrich for their contributions in helping me. As residents, we should not only thank the road crews but all the board members or volunteers who contribute their time and efforts helping out. We cannot make this work without them.

As everyone is aware, our severe weather this spring left all our residents with a big mess. We were able to clear the roads within 24 hours so everyone could get out to the main roads. Volunteers were key in cleaning up our compost area and roadsides of downed trees, limbs, and miscellaneous debris. Some cleanup is still ongoing.

Snow plowing this past winter was lighter than previous years. Ice developed on roads as usual with gravel and sand applied.

Dust control is applied as needed with some challenges as dust control prices have escalated to four times what the cost was just twelve years ago. Keep in mind, dust control is needed but in excess, it is not healthy for our lakes.

## ROADS' REPORT, continued – Rick Applegate

The Speed Limit is 15 MPH. Many people are abusing the speed limit! Remember, you are responsible for the contractors you have working on your home or the company that visits you. Please inform those of our speed limit. People do not pay attention to the speed limit signs. If you see FedEx or UPS going to fast, please get their license plate number and call it in. They will get the message!

The compost area is continuing to shrink. Please use a wood chipper if possible, and do not bring anything larger than 6" in diameter. The dozen 24" diameter logs brought into the compost area recently are not acceptable!

Pole Barn storage is key to extending the life our our Maintainer. We continue to utilize Dan Stevick's pole barn for storage and maintenance issues.

There are several people who regularly help out on our roads such as Tim Ostrosky, Chuck Hopkins, and Kenny Gauci to name a few. We had a great turnout of help that joined us at the compost and west side of Crystal Lake cleaning up debris and running it through the wood chipper. Remember, we cannot have well maintained roads without volunteers so please step up and help! Thank you!

## LAKES' REPORT - Bob Conn

Summer is already upon us, and we have had several lake treatments on Crystal and Perch. The water level started out strong; however it began dropping quickly with 10 rain-free days. A contract was signed with RLS for our ecosystem study, and it will begin on June 14<sup>th</sup>. Pollen was heavy this year resulting in the shore lines looking nasty. Life at the lake is always a challenge to find the balance between nature doing its thing and our tolerating those interruptions. Algae blooms are expected in a lake system that is alive. Hot weather will intensify those natural blooms, and I will try to stay on top of them. Perch had a successful milfoil treatment, but large leaf pond weed will need further management in order to continue use of the lake. Stary Stonewort has now taken over very large parts of both lakes. Studies from the DNR are showing that fish spawning areas will become impacted by this. Stary Stonewort is also a major contributor to floating obstacles in the water as lake temps exceed its ability to thrive, resulting in massive die offs. These dead floating islands create obstacles for boating and swimming.

I hope that everyone has a wonderful happy summer, and I look forward to seeing you at the summer meeting.

The Foundation was busy last year promoting, researching, and vetting profession lake research companies. We are very happy that the Association Board took up this idea and has selected Restorative Lake Services to do a major study of the health of our lakes. We can't wait to see the results.

Anna Marie Asher is now our secretary and newest member. If anyone else would like to be on the foundation, please contact us. We desperately need someone on Perch Lake to help monitor that Lake. It requires very little time; Secchi disk readings every two weeks and spring and fall water samples. It will help to set a baseline so that we can better direct our actions to promote its health.

The emphasis at the annual Michigan Lakes and Streams conference was sewage and shorelines. It is amazing how much nutrients are fed into our lakes by poorly maintained septic systems. If you haven't had yours serviced in a while, please do so for the benefit of our lakes. It is also amazing how our shorelines affect our Lakes. We would like to find someone who would like to be a "shoreland steward". A little on-line or in person training by the state is provided and then you can be the "go-to" person to help all of us with information and advice about how best to treat our shorelines.
